Application is hereby made for a building permit to do the work as described above and in consideration of the issuance of such permit, I agree that this application is subject to being built as referenced to the applicable approved plans and in accordance with the Zoning Ordinance, Building Codes, and other ordinances of the City of Auburndale and laws of the State of Florida applicable thereto. It is understood that any deviation from the information contained herein, unless approved by the Building Official, will render the building permit null and void. Also, the property will not be occupied until after a Letter of Completion or a Certificate of Occupancy is acquired upon completion of all applicable inspections. It is the owner's responsibility to comply with the provisions of Section 469.003, Florida Statues, and to notify the Department of Environmental Protection of his or her intentions to remove asbestos, when applicable, in accordance with state and federal law.

*An Early Start Permit Application is hereby made for an early start permit to do the work as briefly described herein. Early start permits do not include work that is permitted under a separate permit by the City of Auburndale. Work shall not proceed past the first required inspection.

**Driveway/Sidewalk Applicant/Owner acknowledges and accepts all applicable conditions and provisions of the permit by signing this application. Applicant agrees to indemnify, hold harmless, and defend the City of Auburndale. Applicant acknowledges that driveways shall be constructed in accordance with the City of Auburndale Land Development Regulations (which reference the FDOT Sidewalk and Driveway Standard 310 and 515) and the State of Florida Erosion and Sediment Control Designer and Reviewer Manual. Applicant/Owner/Contractor shall provide proof of insurance as required by the City of Auburndale. If access is from a state highway, please contact the Florida Department of Transportation.

In addition to the requirements of this permit, there may be additional restrictions applicable to this property that may be found in the public records of this county, and there may be additional permits required from other governmental entities such as the water management district, state agencies, or federal agencies.

This permit covers: windows, doors, tents, dumpsters, sheds, carports, screen enclosures, retention walls, seawalls, decks, and docks. A separate permit is required for fire sprinklers.
