Each bid must be submitted in a sealed envelope and addressed to the Finance Director, City of Auburndale, and plainly marked in the lower left corner of the envelope "Sealed Bid – Proposal for the City of Auburndale's Municipal Services Building Renovations – Framing & Drywall"

A **mandatory pre-bid meeting** for all interested trades is scheduled for Thursday, November 30, 2023 from 9:00am – 12:00pm at 6 Bobby Green Plaza, Auburndale, Florida.

Proposers are also required to include a completed Non-collusion Affidavit of Prime Bidder Form and PUR 7068 Form with the sealed bid.

The City reserves the right to reject any or all bids, to waive informalities, to re-advertise, and to accept the bid that is in the best interest of the City, which may not necessarily be the lowest bid. Reasonable variations from bid specifications will be considered.

#### **BID SPECIFICATIONS**

- 1. A mandatory pre-bid conference will be held on Thursday, November 30 at 6 Bobby Green Plaza, Auburndale at 9:00am 12:00pm EST.
- 2. The successful bidder will be required to provide the necessary Framing & Drywall services that are specified in the construction plans which are available on the City's website at <a href="http://www.auburndalefl.com/rfps/">http://www.auburndalefl.com/rfps/</a>. Such services shall include, but are not limited to.:
  - a. Framing
    - 1. Provide new framing for office spaces as shown on approved drawings.
  - b. Drywall
    - 1. Provide drywall over new framing and demolition areas. Drywall finish is as shown on approved drawings.
    - 2. All gypsum board to have a smooth finish.
- 3. The successful contractor shall maintain all necessary insurance coverage's as required by local, state and federal law during the term of the project including:
  - a. Workers Compensation Insurance, as required by state law, for all employees engaged in work under this contract.
  - b. Property Damage, Automotive and General Liability Insurance of not less than \$1,000,000 on account of all accidents.
- 4. The successful contractor shall furnish proof of insurance prior to the commencement of the project.
