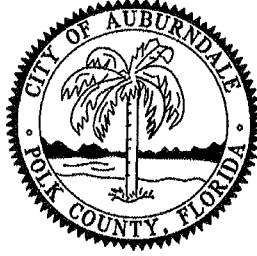

Bids will be for the replacement of 18 baseball bullpen's artificial turf flooring. All bids must be submitted in sealed envelopes, addressed to the City Manager, and plainly marked on the outside, "Sealed Bid – Lake Myrtle – Bullpen Turf."

Bid Specifications and required bid submittal information are available in the Parks and Recreation Department, 119 West Park Street. It is the responsibility of the bidder to deliver his or her bid to the office of the City Manager before the specified time and date.

Bidders are required to submit a completed NONCOLLUSION AFFIDAVIT OF PRIME BIDDER form and PUR 7068 form with the sealed bid. The bidder must also submit documentation of liability and worker's compensation insurance.

The City reserves the right to reject any or all bids, to waive informalities, to re-advertise, and accept the bid in the best interest of the City, not necessarily the lowest bid.

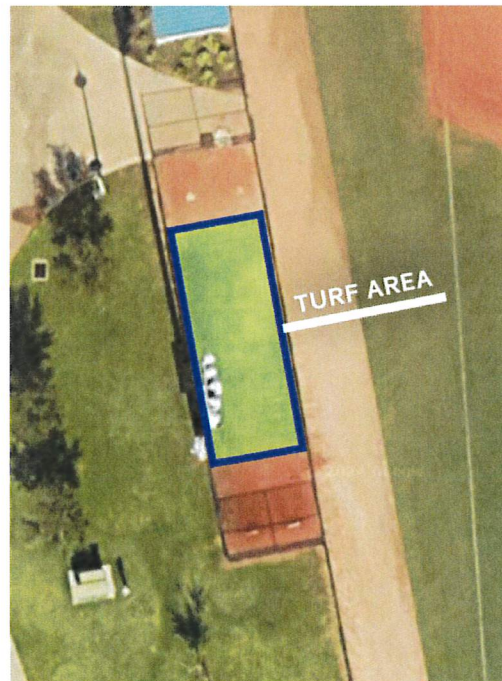

1. A predecessor or successor of a person convicted of a public entity crime; or
 2. An entity under the control of any natural person who is active in the management of the entity and who has been convicted of a public entity crime. The term "affiliate" includes those officers, directors, executives, partners, shareholders, employees, members, and agents who are active in the management of an affiliate. The ownership by one person of shares constituting a controlling interest in another person, or a pooling of equipment or income among persons when not for fair market value under an arm's length agreement, shall be a prima facie case that one person controls another person. A person who knowingly enters into a joint venture with a person who has been convicted of a public entity crime in Florida during the preceding 36 months shall be considered an affiliate.
