The City of Auburndale is seeking proposals from qualified contractors for the re-lamination of Formica cabinets, solid surface countertop installation, and lowering an existing bar area to countertop height at the Auburndale Fire Department. The city will receive sealed bids in the City Manager's Office, Auburndale City Hall, 1 Bobby Green Plaza, Auburndale Florida up until 2:00 p.m. Monday December 16, 2024, for the work which will include, removing existing Formica from kitchen cabinets and entertainment center in the day room. It will also include installation of two drawer-based cabinets with countertops in a report room at the Fire Department located at 100 Ariana Ave, Auburndale FL 33823. All bids must be submitted in a sealed envelope plainly marked on the outside "Sealed Bid - FD Kitchen and Cabinet Improvements"
